This matter is before the Commission upon the Community Action Council for Lexington-Fayette, Bourbon, Harrison and Nicholas Counties, Inc.'s ("CAC") motion for an informal conference for the purpose of reviewing the implementation of the settlement agreement in this matter. Kentucky Utilities Company ("KU") and Louisville Gas and Electric Company ("LG&E"), the applicants herein, have filed a response agreeing to participate in an informal conference but specifically objecting to CAC's assertion that KU and LG&E have failed to comply with the settlement agreement, which had been previously approved by the Commission on March 31, 2008. CAC subsequently filed a reply in support of its motion for an informal conference.

Having reviewed the pleadings and being otherwise sufficiently advised, the Commission will grant CAC's motion for an informal conference.
