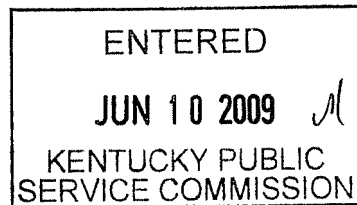
Big Rivers Electric Corporation and E.ON US, LLC, Western Kentucky Energy Corp., and LG&E Energy Marketing, Inc. filed a motion requesting the Commission to schedule an informal conference on June 16, 2009 at 9:00 a.m., Eastern Daylight Time, for the purposes of discussing the outstanding issues related to the closing of the Unwind Transaction and allowing Commission Staff to meet collectively and individually with the parties to the case for the purpose of mediating a resolution of the outstanding issues.

Based on the motion and being otherwise sufficiently advised, the Commission finds good cause to schedule an informal conference. The Commission will make its offices available for the parties to meet collectively and individually. However, the role


of Commission Staff should be limited to meeting collectively with the parties to discuss the outstanding issues and participate in any mediation of the outstanding issues.

IT IS THEREFORE ORDERED that an informal conference shall be held on June 16, 2009 at 9:00 a.m., Eastern Daylight Time, at the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky for the purposes as set forth in the findings above.
