### <u>ORDER</u>

Pending before the Commission is a motion filed by Big Rivers Electric Corporation ("Big Rivers") requesting a 30-day extension of time, from September 14, 2009 to October 14, 2009, to file the Big Rivers New Financial Model. The September 14, 2009 due date was established in accordance with the provisions of the Commission's March 6, 2009 Order at Appendix A, Condition No. 15. In support of its motion, Big Rivers states that a 30-day delay will allow it to, among other things, incorporate the most recent financial projections from its 2010 draft budget, which will be more reflective of future operations.

Based on the unopposed motion and being otherwise sufficiently advised, the Commission finds good cause to grant the request for a 30-day extension of time for the filing of the Big Rivers New Financial Model. The Commission further finds that there

are no further procedural or substantive actions to be taken in this case and, therefore, this case should be closed and removed from the Commission's docket.

## IT IS THEREFORE ORDERED that:

- 1. Big Rivers' motion for a 30-day extension of time is granted and Big Rivers shall file the Big Rivers New Financial Model by October 14, 2009.
  - 2. This case is closed and removed from the Commission's docket.
