ORDER

The parties to this proceeding have advised the Commission that they have reached an agreement on all outstanding issues in this matter and jointly moved the Commission to suspend the existing requirement for submission of written briefs.

Having considered the motion and being otherwise sufficiently advised, the Commission finds that the motion should be granted in part and denied in part. The parties will be permitted until June 1, 2009 to submit to the Commission any written settlement agreement for the Commission's consideration. Upon reviewing the agreement, we will determine whether the submission of written briefs is still necessary. We advise all parties that no settlement agreement may restrict or limit the Commission's statutory authority to enforce the provisions of KRS Chapter 278.


IT IS THEREFORE ORDERED that:
