## ORDER

This matter is before the Commission upon a motion filed by South Kentucky Rural Electric Cooperative Corporation ("South Kentucky") requesting a continuance of the June 9, 2009 hearing and an extension of time to file its testimony. South Kentucky's counsel informs the Commission in the motion that he has a scheduling conflict and will not be able to attend the hearing scheduled for June 9, 2009. South Kentucky also requests an extension of up to and including May 22, 2009 to file testimony. South Kentucky avers that "[t]here is an abundance of information to gather and present and South Kentucky does not believe that it will be able to adequately present the issues to the Commission by means of testimony by the April 28, 2009 deadline." South Kentucky further informs the Commission that its monthly board of directors meeting will occur on May 14, 2009 and that the matters to be presented to the Commission will likely be discussed at that meeting.

  - 3. South Kentucky shall file testimony no later than May 22, 2009.
