ORDER

On November 26, 2008, the Commission entered an Order setting the procedural schedule for this proceeding. It required the Intervenors to file their responses to information requests by March 23, 2009. It also set a deadline for Kentucky-American Water Company's ("Kentucky-American") rebuttal testimony and the date for, *inter alia*, an informal conference.

On March 20, 2009, the Attorney General filed a motion for abeyance of the deadline to file responses to information requests. To support his motion, the Attorney General states that his office and Kentucky-American have tentatively agreed to settlement terms and that they are in contact with the other parties in this case to determine whether settlement is feasible.

The Commission finds good cause to grant the Attorney General's motion and also to suspend the deadline by which Kentucky-American must file testimony of its witnesses. The Commission further finds it appropriate to change the date and time of the informal conference that was previously scheduled for April 9, 2009 to April 6, 2009.

IT IS THEREFORE ORDERED that:

1. The deadlines by which the Attorney General was to file his responses to information requests and Kentucky-American was to file testimony of its rebuttal witnesses shall be held in abeyance.

2. An informal conference will be held at 2:00 p.m., Eastern Daylight Time, on April 6, 2009 at the Commission's offices in Frankfort, Kentucky for the purposes of considering the possibility of settlement, the simplification of issues, and any other matters that may aid in the disposition of this case.

3. The informal conference set for April 9, 2009 is cancelled.

4. All other dates listed on the procedural schedule established on November 26, 2008 shall remain in effect.
