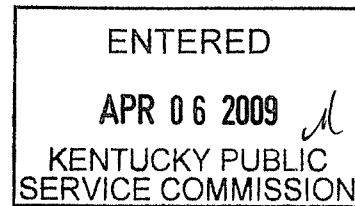
O R D E R

The Commission, on its own motion, HEREBY ORDERS that:

1. Magoffin County Water District ("Magoffin District") is to file with the Commission the original and six copies of the information listed in the Appendix to this Order within 21 days of the date of this Order and serve a copy to all parties of record.
2. Magoffin District's responses to this Order shall be appropriately bound, tabbed and indexed and shall include the name of the witness responsible for responding to the questions related to the information provided.
3. Each response shall be answered under oath or shall be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.
4. Magoffin District shall make timely amendment to any response if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect.

5. For any request to which Magoffin District fails or refuses to furnish all or part of the requested information, it shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.
