O R D E R

On November 17, 2008, Adair County Water District ("Adair County") applied for authority to increase certain nonrecurring charges. Adair County has provided adequate evidence of the individual expenses incurred to provide the services associated with the proposed charges.

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. The proposed charges are equal to the expenses incurred to provide the associated services.
2. The charges and policies set forth in the Appendix to this Order are fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. The charges in the Appendix are approved for services rendered on and after the date of this Order.
2. Within 20 days of the date of this Order, Adair County shall file with the Commission revised tariff sheets setting out the charges approved in Appendix A.
