O R D E R

On November 20, 2008, Southern Madison Water District ("Southern Madison") submitted an application for authority to revise certain nonrecurring charges. The Commission rejected the application due to filing deficiencies. On December 10, 2008, Southern Madison supplemented its application and cured its deficiencies.

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Southern Madison did not provide the Commission 30 days' prior notice of the increase in accordance with KRS 278.180(1) or submit tariff sheets stating a valid effective date as 807 KAR 5:011, Section 6, requires.¹

2. The proposed charges are equal to the expenses incurred to provide the associated services.

3. The charges and policies set forth in the Appendix to this Order are fair, just, and reasonable and should be approved.

¹ The proposed effective date of January 1, 2009 did not provide the Commission with 30 days' notice and it is, therefore, not valid.


IT IS THEREFORE ORDERED that:
