ORDER

On February 13, 2009, the Commission established a procedural schedule for the orderly processing of the discovery portion of this proceeding. The procedural schedule provided that the hearing date and the date for simultaneous briefs, if any, would be determined at a later date. On July 15, 2009, Duke Energy Kentucky, Inc. ("Duke Kentucky") moved the Commission to complete the procedural schedule by setting this matter for a hearing and establishing the date for simultaneous briefs. Due to the availability of its witnesses, Duke Kentucky requests that the Commission schedule the hearing after August 21, 2009.

The Commission, being sufficiently advised, HEREBY ORDERS that:

1. A formal public hearing is scheduled to commence at 10:00 a.m., Eastern Daylight Time, on August 27, 2009 in Hearing Room 1 of the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky for the purposes of cross-examination of the witnesses of Duke Kentucky and intervenors that have filed prepared testimony in this proceeding.
2. Duke Kentucky shall publish notice of the hearing no later than August 20, 2009.

3. The date for filing of simultaneous briefs, if any, shall be established at the formal public hearing.
