ORDER

Alleging an error in our Order of May 22, 2009, Ledbetter Water District (“Ledbetter District”) has moved for rehearing of that Order in which we approved the water district’s proposed rate adjustment. Having considered the Motion and reviewed the Order of May 22, 2009, we find that, while we expressly approved “Ledbetter’s proposed sewer rates,” the rates set forth in Appendix A to that Order were not the proposed rates.¹ Accordingly, we find that the Motion for Rehearing should be granted and that our Order of May 22, 2009 should be amended to substitute the proposed rates for those appended to that Order.

IT IS THEREFORE ORDERED that Ledbetter District’s Motion for Rehearing is granted.

IT IS FURTHER ORDERED, *nunc pro tunc*, that Appendix A to the Order of May 22, 2009 is stricken and Appendix A to this Order is substituted.

¹ Commission Staff apparently made a similar error when preparing its report on the proposed rate adjustment. While Commission Staff found that Ledbetter’s proposed rates would generate annual revenues of \$384,098, were reasonable, and should be approved, it listed a different set of rates in Appendix C of its report as the recommended rates. As nothing in the report indicates that Commission Staff opposed acceptance of the proposed rates or questioned their reasonableness, we assume that Commission Staff mistakenly stated the rates that are found in Appendix C of its report.
