O R D E R

Pursuant to 807 KAR 5:056, Section 1(12), IT IS HEREBY ORDERED that:

1. A public hearing shall be held on March 17, 2009 at 10:00 a.m., Eastern Daylight Time, at the Commission's offices in Frankfort, Kentucky, to examine the application of the fuel adjustment clause of Nolin Rural Electric Cooperative Corporation ("Nolin") from November 1, 2006 to October 31, 2008. If no interested party files written notice of its intent to attend this hearing with the Commission by March 13, 2009, the public hearing shall be cancelled.
2. Nolin shall file with the Commission, not later than 21 days from the date of this Order, an affidavit attesting to its compliance or noncompliance with the requirements of 807 KAR 5:056.
3. Nolin shall publish the following notice not less than 7 days nor more than 21 days prior to the public hearing in a newspaper of general circulation in its service areas or in a trade publication or newsletter going to all customers. Nolin shall also file an Affidavit of Publication of Hearing Notice with the Commission when received from the publisher, but no later than March 13, 2009.

A public hearing will be held on Tuesday, March 17, 2009, at 10:00 a.m., Eastern Daylight Time, at the offices of the Kentucky Public Service Commission, 211 Sower Boulevard, Frankfort, Kentucky, to examine the application of the fuel adjustment clause of Nolin Rural Electric Cooperative Corporation for the period November 1, 2006 to October 31, 2008. Individuals interested in attending this hearing shall notify the Public Service Commission in writing of their intent to attend no later than March 13, 2009. If no notices of intent to attend are received by that date, this hearing will be cancelled. Written notice of intent to attend this hearing should be sent to: Jeff Derouen, Executive Director, Kentucky Public Service Commission, P.O. Box 615, Frankfort, Kentucky 40602.

4. Nolin shall, not later than 30 days from the date of this Order, file with the Commission the original and 5 copies of the information listed in Appendix A. Each copy shall be placed in a bound volume with each item tabbed. When numerous sheets are required for an item, each sheet should be appropriately indexed; for example, Item 1(a), Sheet 2 of 6. Nolin shall furnish with each response the name of the witness who will be available at the public hearing to respond to questions concerning each area of information requested. Nolin shall ensure that copied material is legible.

## APPENDIX A

### APPENDIX TO AN ORDER OF THE KENTUCKY PUBLIC SERVICE COMMISSION IN CASE NO. 2008-00533 DATED JANUARY 23, 2009

1. a. Provide a schedule of the calculation of the 12-month average line loss by month for November 2006 through October 2008.

b. Describe the measures that Nolin has taken to reduce line loss during this period.

2. Provide a schedule showing the calculation of monthly over- or under-recovery of fuel costs from November 1, 2006 through October 31, 2008.

3. Provide Nolin's monthly revenue reports (monthly billing summaries) showing the total revenue collected, including adjustments under the fuel adjustment clause, reported in Nolin's monthly filings required by the Commission from November 1, 2006 through October 31, 2008.

4. Provide a schedule showing the calculation of the increase or decrease in Nolin's base fuel costs per kWh as proposed by its wholesale electric supplier adjusted for Nolin's 12-month average line loss for November 2006 through October 2008.

5. Provide a schedule of the present and proposed rates that Nolin seeks to change pursuant to 807 KAR 5:056 as calculated in item 4 above, shown in comparative form.

6. Provide a statement showing, by cross-outs and italicized inserts, all proposed changes in rates. A copy of the current tariff may be used.
