ORDER

On December 23, 2008, Peaks Mill Water District ("Peaks Mill") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

Having reviewed the record and being otherwise sufficiently advised, the Commission finds that:

- 1. Peaks Mill purchases water from the Kentucky-American Water Company ("Kentucky-American") and the Frankfort Electric and Water Plant Board ("Frankfort").
- 2. The wholesale rate that Frankfort charges to Peaks Mill is composed of two rate components: general rate and Kentucky River Authority Withdrawal Fee rate.
- 3. On November 30, 2008, Frankfort adjusted its Kentucky River Authority Withdrawal Fee rate from \$0.05 per 1,000 gallons to \$0.0965 per 1,000 gallons to reflect increases in the fees that the Kentucky River Authority assesses for withdrawal of water from the Kentucky River.

- 4. On December 8, 2008, Frankfort adjusted its general rate from \$1.539 per 1,000 gallons to \$1.822 per 1,000 gallons pending final action in Case No. 2008-00250.²
- Peaks Mill proposes to adjust its rates to reflect the increase in both rate components.
- 6. In applying the purchased water adjustment procedures set forth in 807 KAR 5:068, each component of Frankfort's wholesale rate should be considered a separate rate and adjusted individually, not collectively. The individual rate components should not be combined and considered as one rate.
- 7. During the 12 months ending October 31, 2008, Peaks Mill purchased 86,126,100 gallons of water from Frankfort and 507,000 gallons of water from Kentucky-American. Peaks Mill sold a total of 66,031,900 gallons. The total increase cost of purchased water is \$28,378.55, which results in a purchased water adjustment of \$0.43 per 1,000 gallons.
- 8. The calculations shown in Appendix A to this Order reflect the proper calculation of the purchased water adjustment factor.
- 9. In calculating the effects of the adjustment, Peaks Mill misstated the base rate and incorrectly adjusted its rates based on the factor.
- 10. A purchased water adjustment of \$0.43 per 1,000 gallons is fair, just and reasonable.

IT IS THEREFORE ORDERED that:

- 1. Peaks Mill's proposed rates are denied.
- 2. A purchased water adjustment of \$0.43 per 1,000 gallons is approved.
- 3. The rates set forth in Appendix B to this Order are approved for service that Peaks Mill renders on and after the date of this Order.
- 4. Within 20 days of the date of this Order, Peaks Mill shall file with the Commission revised tariff sheets containing the approved rates.
