#### ORDER

On December 29, 2008, North Shelby Water Company ("North Shelby") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

Having reviewed the record and being otherwise sufficiently advised, the Commission finds that:

- 1. North Shelby purchases water from Louisville Water Company, City of Shelbyville ("Shelbyville"), Frankfort Electric and Water Plant Board ("Frankfort"), and West Shelby Water District.
- 2. The wholesale rate that Frankfort charges to North Shelby is composed of two rate components: general rate and Kentucky River Authority Withdrawal Fee rate.
- 3. On December 8, 2008, Frankfort increased its general rate from \$1.539 per 1,000 gallons to \$1.822 per 1,000 gallons pending final action in Case No. 2008-00250.<sup>2</sup>

- 4. On December 10, 2008, North Shelby's Board of Directors voted to adjust the water association's rates to reflect the increase in the general rate component effective immediately.
- 5. In applying the purchased water adjustment procedures set forth in Administrative Regulation 807 KAR 5:068, each rate component of Frankfort's wholesale should be considered a separate rate and adjusted individually, not collectively. The individual rate components should not be combined and considered as one rate.
- 6. During the 12 months ending November 30, 2008, North Shelby purchased 478,136,860 gallons of water and sold a total of 382,534,000 gallons. The total increase cost of purchased water is \$50,492.58, which results in a purchased water adjustment of \$0.13 per 1,000 gallons.
- 7. The calculations shown in Appendix A to this Order reflect the proper calculation of the purchased water adjustment factor.
- 8. In calculating the effects of the adjustment, North Shelby misapplied the adjustment factor to its current rates.
- 9. A purchased water adjustment of \$0.13 per 1,000 gallons is fair, just and reasonable.

#### IT IS THEREFORE ORDERED that:

- 1. North Shelby's proposed rates are denied.
- 2. A purchased water adjustment of \$0.13 per 1,000 gallons is approved.
- 3. The rates set forth in Appendix B to this Order are approved for services that North Shelby renders on and after the date of this Order.
- 4. Within 20 days of the date of this Order, North Shelby shall file with the Commission revised tariff sheets containing the approved rates.
