ORDER

On October 10, 1986, in Case No. 9565,¹ the Commission approved rates for Public Gas Company ("Public") and provided for their further adjustment in accordance with Public's Gas Cost Adjustment ("GCA") clause.

On December 30, 2008, Public filed its proposed GCA to be effective February 1, 2009.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Public's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
2. Public's proposed Expected Gas Cost ("EGC") is \$7.2309 per Mcf, which is a decrease of \$2.5012 per Mcf from the previous EGC of \$9.7321.
3. Public's notice sets out no current quarter Refund Adjustment.
4. Public's notice sets out a current quarter Actual Adjustment ("AA") of (\$.3595) per Mcf. Public's notice sets out a total AA of \$.2049 per Mcf, which is a decrease of \$.3211 per Mcf from the previous total AA of \$.5260.

5. Public's GCA is \$7.4358 per Mcf, which is \$2.8223 per Mcf less than the previous GCA of \$10.2581.

6. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for billing for service rendered by Public on and after February 1, 2009.

IT IS THEREFORE ORDERED that:


1. The rates in the Appendix, attached hereto and incorporated herein, are approved for billing for service rendered on and after February 1, 2009.

2. Within 20 days of the date of this Order, Public shall file with this Commission its revised tariffs setting out the rates authorized herein.
