ORDER

On January 21, 2009, Union County Water District ("Union District") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- Union District purchases water from the city of Morganfield ("Morganfield").
- 2. Morganfield notified Union District that it will decrease its wholesale water rate effective December 31, 2008. Morganfield's wholesale water rate to Union District would decrease from \$1.645 per 1,000 gallons to \$1.3487 per 1,000 gallons. Union District proposes to decrease the water rates to its customers effective December 31, 2008.
- 3. KRS 278.015 requires a public utility to file its revised tariffs within 20 days after it increases its rates commensurate with its supplier's increase in rates.

- 4. Union District's filing of January 21, 2009 was not within 20 days after its December 31, 2008 proposed increase.
- 5. Union District's application contained a mathematical error in the purchase water factor and subsequently in the computation of the proposed rates.
- 6. During the 12 months ending November 30, 2008, Union District purchased a total of 270,027,900 gallons of water from Morganfield. The decrease in the cost of purchased water is \$80,009.27, resulting in a purchased water adjustment decrease of \$0.32 per 1,000 gallons.
- 7. The purchased water adjustment decrease of \$0.32 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

- 1. Union District's proposed rates are denied.
- 2. Union District's proposed effective date is denied.
- 3. The purchased water adjustment decrease of \$0.32 per 1,000 gallons as calculated in Appendix A is approved and the rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services rendered on and after the date of this order.
- 4. Within 20 days of the date of this Order, Union District shall file with the Commission revised tariff sheets showing the rates approved herein.
