DATA REQUEST OF COMMISSION STAFF TO THE  
CITY OF BURKESVILLE AND CUMBERLAND COUNTY WATER DISTRICT

Pursuant to 807 KAR 5:001, the city of Burkesville ("Burkesville") and Cumberland County Water District ("Cumberland District") are to file with the Commission the original and seven copies of the following information, with a copy to all parties of record. The information requested herein is due on or before August 12, 2009. Responses to requests for information shall be appropriately bound, tabbed and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Burkesville and Cumberland District shall make timely amendment to any prior response if they obtain information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For

any request to which Burkesville and Cumberland District fail or refuse to furnish all or part of the requested information, Burkesville and Cumberland District shall provide a written explanation of the specific grounds for their failure to completely and precisely respond.

Careful attention should be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations.


For Burkesville

1. In response to item 6 of Staff's First Data Request, Burkesville stated that the water for plant use during the test period for the Cost of Service Study of 2005 was 18,004,000 gallons and, during the fiscal year ending June 30, 2008, was 16,382,000 gallons. Explain what is included in these numbers for plant use and why so much water is used at the plant in comparison to the amount of sales.

For Cumberland District

2. Provide the name of each wholesale supplier and the amount of water purchased from each during calendar year 2008.

3. Provide the estimated number gallons that Cumberland District plans to purchase from Burkesville during the 2010 calendar year.
