ORDER

On February 23, 2009, Nebo Water District ("Nebo") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. Nebo purchases water from the City of Madisonville ("Madisonville").
- 2. Madisonville notified Nebo that, effective March 1, 2009 its wholesale rate to Nebo would increase from \$3.27 per 1,000 gallons to \$3.59 per 1,000 gallons.
- 3. Nebo proposed a purchased water adjustment factor of \$0.40 per 1,000 gallons.
- 4. Nebo proposed to increase the rates to its customers effective March 8, 2009.
- 5. During the 12 months ended December 31, 2008, Nebo purchased 145,651,000 gallons of water from Madisonville and sold 116,077,000 gallons. The

increase in the cost of purchased water is \$46,608.32, resulting in a purchased water adjustment factor of \$0.40 per 1,000 gallons.

6. The purchased water adjustment factor of \$0.40 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

- 1. The rates proposed by Nebo are accepted.
- 2. The purchased water adjustment factor of \$0.40 per 1,000 gallons as calculated in Appendix A is approved.
- 3. The rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services on or after March 8, 2009.
- 4. Within 20 days of the date of this Order, Nebo shall file with the Commission revised tariff sheets showing the rates approved herein.
