ORDER

On September 30, 1991, in Case No. 1990-00402, the Commission approved certain adjusted rates for Martin Gas, Inc. ("Martin").¹ In November 2004, Martin proposed, and the Commission approved, changes to its tariff that included, among other items, changes to its Gas Cost Adjustment Clause ("GCA"). Those changes updated the methodology of calculating the components of the GCA.

On March 4, 2009, Martin filed a GCA for rates to be effective January 1, 2009. After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Martin's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.

2. Martin's notice sets out an expected gas cost ("EGC") of \$5.1537 per Mcf. Martin's current supply contract with Clean Gas prices the natural gas purchased by Martin at \$5.00 per Mcf. Using information provided by Martin concerning purchases and sales volumes for the 12 months ended December 31, 2008, staff has recalculated the EGC based on \$5.00 per Mcf. The revised EGC is \$5.0000, which is a decrease of \$.0064 per Mcf from its prior EGC of \$5.0064.

3. Martin's notice sets out no refund adjustment ("RA") for the current quarter and no total RA, which is no change from the prior total RA.

4. Martin's notice sets out a current quarter Actual Adjustment ("AA") of \$.0012968 per Mcf for the period July 2008 through September 2008. Martin calculated its AA using an incorrect EGC. Staff recalculated the current quarter AA using the EGC that was actually in effect July through September. The calculation of Martin's current quarter AA is shown below:

Martin's total AA of (\$.0035) is comprised of the current quarter AA of (\$.0036) and a previous quarter AA of \$.0001, and represents a decrease of \$.0036 from the previous quarter.

5. Martin's notice sets out no Balance Adjustment.

6. Martin's GCA is \$4.9965 per Mcf, which is a decrease of \$.0100 per Mcf from its previous rate of \$5.0065.

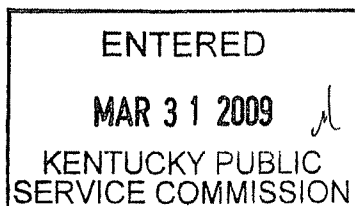
7. Martin's proposed effective date of January 1, 2009 would constitute retroactive ratemaking, which is prohibited and should be denied.

8. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for billing for service rendered by Martin on and after April 1, 2009.


IT IS THEREFORE ORDERED that:

1. Martin's proposed rates are denied.

3. Within 20 days of the date of this Order, Martin shall file with the Commission its revised tariff sheets setting out the rates authorized herein.
