ORDER

On March 12, 2009, Henderson County Water District ("Henderson") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. Henderson purchases water from the North Henderson Water Utility ("North Henderson") and from the South Henderson Water Utility ("South Henderson").
- 2. North Henderson and South Henderson notified Henderson that, effective with their April 1, 2009 billings, their wholesale water rates would increase from \$1.6716 per 1,000 gallons to \$1.6903 per 1,000 gallons and from \$1.7096 per 1,000 gallons to \$2.0506 per 1,000 gallons, respectively. Henderson proposes to increase the water rates to its customers effective April 1, 2009.
- 3. During the 12 months ending December 31, 2008, Henderson purchased 562,093,100 gallons of water and sold 414,301,357 gallons. The increase in the cost of purchased water is \$25,996.72, resulting in a purchased water adjustment of \$0.06 per 1,000 gallons.

- 4. The rates proposed by Henderson should be approved.
- 5. The purchased water adjustment of \$0.06 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

- 1. The rates proposed by Henderson are approved.
- 2. The purchased water adjustment of \$0.06 per 1,000 gallons as calculated in Appendix A is approved.
- 3. The rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services on and after April 1, 2009.
- 4. Within 20 days of the date of this Order, Henderson shall file with the Commission revised tariff sheets showing the rates approved herein.

The monthly charge for water usage in excess of the respective minimum water rates set out above shall be computed in increments of 10 gallons. Accordingly, a customer having a 5/8 inch meter who consumes at least 2,010 gallons of water and not more than 2,019 gallons of water in any month shall pay the amount of \$14.78 for the month (\$14.73 plus \$0.05). A customer having a 5/8 inch meter who consumes at least 2,020 and not more than 2,029 gallons of water in any month shall pay the amount of \$14.83 for that month (\$14.73 plus \$0.10).
