ORDER

This matter arises upon the motion of Homestead Manufactured Home Community; Yarwood Mobile Home Park, LLC; Country Lane Mobile Home Park; Duvall Mobile Home Park; Masden Mobile Home Park, LLC; Lynch's Mobile Home Park; Golden Rainbow Mobile Home Park, Inc.; Parkside Manor MHP Radcliff, LLC; Rogersville Mobile Home Park; and Paradise Mobile Home Park, LLC (collectively "Mobile Home Communities"), filed April 16, 2009 for full intervention. It appears to the Commission that such intervention is likely to present issues and develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings. The Commission, being otherwise sufficiently advised, finds that the Mobile Home Communities should be granted full rights of a party in this proceeding.

¹ Several of the owners and managers of these communities also filed individual requests to intervene. Because the Commission finds that intervention is proper for the collective group and that all the individual requests are affiliated with entities included within the request by the Mobile Home Communities, the individual requests are moot.

IT IS HEREBY ORDERED that:

- 1. The motion of the Mobile Home Communities to intervene is granted.
- 2. The Mobile Home Communities shall be entitled to the full rights of a party and shall be served with the Commission's Orders and with filed testimony, exhibits, pleadings, correspondence, and all other documents submitted by parties after the date of this Order.
- 3. Should the Mobile Home Communities file documents of any kind with the Commission in the course of these proceedings, Mobile Home Communities shall also serve a copy of said documents on all other parties of record.
- 4. The individual request for intervention of Isaac Masden filed on March 23, 2009 is denied as moot.
- 5. The individual requests for intervention of James Duvall filed on March 26, 2009 and April 17, 2009 are denied as moot.
- 6. The individual request for intervention of Roger L. Washburn filed on April 14, 2009 is denied as moot.
- 7. The individual request for intervention of Robert Lynch filed on April 14, 2009 is denied as moot.
- 8. The individual request for intervention of Burnis and Kathy Bragg filed on April 17, 2009 is denied as moot.
- 9. The individual request for intervention of Harold LeVay filed on April 20, 2009 is denied as moot.
