ORDER

On October 19, 2007, in Case No. 2007-00089,¹ the Commission approved rates for Delta Natural Gas Company, Inc. ("Delta") and provided for their further adjustment in accordance with Delta's Gas Cost Adjustment ("GCA") clause.

On March 20, 2009, Delta filed its proposed GCA to be effective April 27, 2009. After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. Delta's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. Delta's notice sets out an Expected Gas Cost ("EGC") of \$5.8805 per Mcf, which is a decrease of \$2.4545 per Mcf from the previous EGC of \$8.3350 per Mcf.
- 3. Delta's notice sets out no current quarter Refund Adjustment ("RA"), which is no change from the previous total RA.

- 4. Delta's notice sets out a current quarter Actual Adjustment ("AA") of \$2.0192 per Mcf. Delta's total AA is \$3.6822 per Mcf, which is an increase of \$.2979 per Mcf from the previous total AA of \$3.3843 per Mcf.
- 5. Delta's notice sets out a Balance Adjustment ("BA") of (\$.0519) per Mcf, which represents a decrease of \$.0801 per Mcf from the previous BA of \$.0282 per Mcf.
- 6. Delta's GCA is \$9.5108 per Mcf, which is a decrease of \$2.2367 per Mcf from the previous GCA of \$11.7475 per Mcf.
- 7. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for final meter readings by Delta on and after April 27, 2009.

IT IS THEREFORE ORDERED that:

- 1. The rates in the Appendix to this Order are approved for final meter readings on and after April 27, 2009.
- 2. Within 20 days of the date of this Order, Delta shall file with this Commission its revised tariffs setting out the rates authorized herein.
