# ORDER

On April 30, 2001, in Case No. 2001-00027, the Commission approved the transfer of the Phelps portion of the Mike Little Gas Co., Inc. ("Mike Little") system to People's Gas, Inc. ("People's") and provided for the adjustment of rates on a quarterly basis in accordance with Mike Little's Gas Cost Adjustment ("GCA") clause, which People's adopted and ratified as ordered in paragraph 3 of the Commission's Order approving the transfer.<sup>1</sup>

On April 13, 2009, People's filed its scheduled quarterly GCA compliance filing for the calendar quarter beginning May 1, 2009. People's' GCA represents no change in rates from those established in its interim filing in Case No. 2009-00098<sup>2</sup> effective April 1, 2009.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. People's' notice includes no change in its wholesale gas costs.

- 2. People's' notice sets out an Expected Gas Cost ("EGC") of \$11.2767, which represents no change from its previous filing.
  - 3. People's' notice sets out no current quarter Refund Adjustment.
- 4. People's' notice sets the current quarter Actual Adjustment ("AA") of \$.7337 approved in its previous filing. People's' total AA is \$2.2100 per Mcf, which represents no change from its previous total AA.
- 5. People's' notice proposes the current quarter and total Balance Adjustment ("BA") of (\$.1347) approved in its previous filing. This represents no change from its previous total BA.
- 6. People's' GCA is \$13.3520 per Mcf, which represents no change from its previous rate.
- 7. On or before July 1, 2009, People's should file its quarterly GCA for the calendar quarter beginning August 1, 2009.

# IT IS THEREFORE ORDERED that:

- 1. The rates proposed by People's for the calendar quarter beginning May 1, 2009 are approved as established in the Commission's Order dated March 31, 2009 in Case No. 2009-00098.
  - 2. No revision of People's' tariffs is required.
- 3. On or before July 1, 2009, People's shall file its quarterly GCA for the calendar quarter beginning August 1, 2009.
