# ORDER

On May 7, 2009, Big Sandy Water District ("Big Sandy") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. Big Sandy purchases water from the city of Louisa ("Louisa"), city of Kenova ("Kenova"), Rattlesnake Ridge Water District ("Rattlesnake Ridge") and the Cannonsburg Water District ("Cannonsburg").
- 2. Cannonsburg raised its wholesale rate to Big Sandy effective April 13, 2009 from \$1.74 per 1,000 gallons to \$2.32 per 1,000 gallons.
- 3. Big Sandy proposed a purchased water adjustment factor of \$0.14 per 1,000 gallons.
  - 4. Big Sandy proposed an effective date of July 1, 2009.
- 5. During the 12 months ended March 31, 2009, Big Sandy purchased 75,398,300 gallons of water from Louisa, 208,415,000 gallons from Kenova, 4,450,940 gallons from Rattlesnake Ridge, and 60,494,800 gallons from Cannonsburg; and it sold

257,546,800 gallons. The increase in the cost of purchased water is \$35,087, resulting in a purchased water adjustment factor of \$0.14 per 1,000 gallons.

6. The purchased water adjustment factor of \$0.14 per 1,000 gallons is fair, just, and reasonable and should be approved.

#### IT IS THEREFORE ORDERED that:

- 1. The rates proposed by Big Sandy are approved.
- 2. The purchased water adjustment factor of \$0.14 per 1,000 gallons as calculated in Appendix A is approved.
- 3. The rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services on or after July 1, 2009.
- 4. Within 20 days of the date of this Order, Big Sandy shall file with the Commission revised tariff sheets showing the rates approved herein.
