SECOND INFORMATION REQUEST OF COMMISSION STAFF TO FARMDALE WATER DISTRICT

Farmdale Water District ("Farmdale"), pursuant to 807 KAR 5:001, is to file with the Commission the original and five copies of the following information, with a copy to all parties of record. The information requested herein is due within ten days from the date of issuance of this data request. Responses to requests for information shall be appropriately bound, tabbed and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Farmdale shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which

Farmdale fails or refuses to furnish all or part of the requested information, it shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations.

- 1. Refer to Responses 7 and 10 to Commission Staff's June 26, 2009 data request. State whether Farmdale provided refunds to its customers in June 2009 or planned to provide refunds in July 2009. Clearly state when refunds were or will be provided to Farmdale's customers.
- 2. Refer to Response 10 to Commission Staff's June 26, 2009 data request. Explain in detail and provide calculations to show how Farmdale calculated the two proposed refunds of \$0.10 per 1,000 gallons.
- 3. Identify the total amount of refunds given to Farmdale's customers for each month during which refunds have been given.
- 4. Identify the total amount of refunds that Farmdale plans to provide to its customers in the future, if any.
- 5. Identify the total amount of refunds that Farmdale customers have received or will receive as a result of Frankfort Electric and Water Plant Board's refunds to Farmdale.

6. Identify separately the amount of gallons of water sold by Farmdale in March, April, May, and June 2009.
