#### ORDER

On September 10, 2009, Windstream Kentucky East, LLC ("Windstream") and New Cingular Wireless PCS, LLC d/b/a AT&T Mobility ("AT&T") filed a Proposed Joint Procedural Schedule ("Joint Schedule") for this arbitration proceeding. This Joint Schedule includes dates for the formal hearing before the Commission.

It is imperative that the Commission receive appropriate information. Amended procedural schedules in this matter may be issued by the Commission by separate Order, if required.

The Commission, being sufficiently advised, HEREBY ORDERS that:

1. The parties shall abide by the Joint Procedural Schedule, as filed on September 11, 2009, unless otherwise ordered by the Commission.

2. The formal hearing for this matter shall take place on January 20 and 21, 2010, beginning at 10:00 a.m., Eastern Standard Time, in Hearing Room 1 of the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky.

3. The official record of these proceedings shall be by court reporter, who shall provide a written transcript of the hearing.

4. Any request to cancel or postpone this formal hearing shall be made by motion filed with the Commission at least one week before the hearing is scheduled to commence.
