ORDER

On July 9, 2009, Complainant, Linglee Su, filed a complaint against Defendant, Kentucky Utilities Company ("KU"). In her complaint, Linglee Su claims that the water meter at a property that she owns at 272 Kimberly Heights, Nicholasville, Kentucky "was broken." Her complaint states that, as a result of the malfunctioning meter, KU incorrectly read the meter and, as a result, she believes she was overcharged for service rendered.

The Commission finds that, because KU is an electric utility and does not provide water service, it is likely that the Complainant is referring to an electric meter and a bill for electric service, rather than a water meter and a bill for water service. However, the Commission finds that the July 9, 2009 complaint, as presently filed, does not describe with sufficient specificity the Complainant's grievances against KU in order for the Commission to determine, pursuant to 807 KAR 5:001, Section 12(4)(a), whether it establishes a prima facie case.

The Complainant has previously provided to the Commission's Division of Consumer Services four printouts of digital photographs of an electric meter hand-dated

April 2, 2009 and April 6, 2009 and a photocopy of a KU electric bill for the Nicholasville property dated June 2, 2009. The Commission is returning the digital photograph prints and the copy of the June 2, 2009 KU bill to Complainant in the event she wishes to attach them to an amended complaint.

Based upon the foregoing, IT IS HEREBY ORDERED that:

- 1. Complainant, Linglee Su, shall be allowed to amend the July 9, 2009 complaint within 20 days of the date of service of this Order to state fully, clearly, and with reasonable certainty the acts or things allegedly done or not done by the Defendant, KU, which form the substance of the complaint.
- 2. The amended complaint shall make reference, where practicable, to the law(s), regulation(s), or order(s) of which a violation is claimed and any other matters or facts necessary to inform the Commission regarding the details of the alleged violation.
- 3. If Complainant chooses to attach any documents or exhibits in support of the amended complaint, Complainant shall include in the amended complaint a detailed description of how each document or exhibit supports the allegations made in the amended complaint.
- 4. Failure to amend the complaint within 20 days of the date of service of this Order, or such extension thereof as the Commission, for good cause shown, may grant, shall result in the dismissal of the complaint, pursuant to 807 KAR 5:001, Section 12(4)(b).






