## ORDER

Pursuant to 807 KAR 5:056, Section 1(11), IT IS HEREBY ORDERED that:

- 1. A public hearing shall be held on October 13, 2009 at 10:00 a.m., Eastern Daylight Time, at the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky, to examine the application of the fuel adjustment clause of Inter-County Energy Cooperative Corporation ("Inter-County") from November 1, 2008 through April 30, 2009. If no interested party files written notice of its intent to attend this hearing with the Commission by October 9, 2009, this public hearing shall be cancelled.
- 2. Inter-County shall file with the Commission, no later than 21 days from the date of this Order, an affidavit attesting to its compliance or noncompliance with the requirements of 807 KAR 5:056.
- 3. Inter-County shall publish the following notice no less than seven days nor more than 21 days prior to the public hearing in a newspaper of general circulation in its service areas or in a trade publication or newsletter going to all customers. Inter-County

shall file an Affidavit of Publication of Hearing Notice with the Commission no later than October 9, 2009.

A public hearing will be held on Tuesday, October 13, 2009, at 10:00 a.m., Eastern Daylight Time, at the offices of the Public Service Commission, 211 Sower Boulevard, Frankfort, Kentucky, to examine the application of the Fuel Adjustment Clause of Inter-County Energy Cooperative Corporation for the period November 1, 2008 through April 30, 2009. Individuals interested in attending this hearing shall notify the Public Service Commission in writing of their intent to attend no later than October 9, 2009. If no notices of intent to attend are received by that date, this hearing will be cancelled. 4. The official record of the proceeding shall be by video only, unless otherwise requested by a party to this proceeding.
