A public hearing will be held on Tuesday, October 13, 2009, at 10:00 a.m., Eastern Daylight Time, at the offices of the Public Service Commission, 211 Sower Boulevard, Frankfort, Kentucky, to examine the application of the Fuel Adjustment Clause of Nolin Rural Electric Cooperative Corporation for the period November 1, 2008 through April 30, 2009. Individuals interested in attending this hearing shall notify the Public Service Commission in writing of their intent to attend no later than October 9, 2009. If no notices of intent to attend are received by that date, this hearing will be cancelled.
