ORDER

On August 3, 2009, Judy Water Association ("Judy Water") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹ On August 6, 2009, Judy Water filed an additional application and information correcting some errors in the August 3, 2009 filing.

The Commission, having reviewed the record and being sufficiently advised, finds that:

- Judy Water purchases water from the Mt. Sterling Water & Sewer System ("Mt. Sterling") and the city of North Middleton ("North Middleton").
- 2. North Middleton notified Judy Water that it will increase its wholesale water rate effective August 16, 2009. North Middleton's wholesale water rate to Judy Water would increase from \$2.97 per 1,000 gallons to \$3.62 per 1,000 gallons for the first 70,000 gallons of water per day and from \$3.07 per 1,000 gallons to \$3.72 per 1,000 gallons of water for any over 70,000 gallons per day. Judy Water proposes to increase the water rates to its customers effective August 20, 2009.

3. During the 12 months ending June 30, 2009, Judy Water purchased a total of 116,794,300 gallons of water from Mt. Sterling and purchased a total of 51,668,000 gallons of water from North Middleton and sold a total of 149,200,000 gallons of water. The increase in the cost of purchased water is \$33,584.20, resulting in a purchased water adjustment of \$0.23 per 1,000 gallons.

4. A purchased water adjustment of \$0.23 per 1,000 gallons is fair, just, and reasonable.

IT IS THEREFORE ORDERED that:

- 1. Judy Water's proposed rates are approved.
- 2. The purchased water adjustment increase of \$0.23 per 1,000 gallons as calculated in Appendix A is approved and the rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services rendered on and after August 20, 2009.
 - 3. The tariff sheets filed by Judy Water in the application are approved.
