ORDER

On August 24, 2009, Montgomery County Water District No. 1 ("Montgomery District") tendered its application for rate adjustment pursuant to 807 KAR 5:076. Because of filing deficiencies, the Commission did not accept the application for filing until September 3, 2009. In order to perform its limited review of Montgomery District's test-period operations, Commission Staff issued an information request on October 30, 2009 directing Montgomery District to submit its responses by November 14, 2009.

On November 5, 2009, Montgomery District submitted a letter stating that 807 KAR 5:076 provides for a simplified and less expensive procedure for small utilities to apply for rate adjustments and that, given its size, Montgomery District cannot afford the expense of filing a costly rate case. For these reasons, Montgomery District believes it has met the requirements of the applicable regulation and requests the Commission to grant it all deviations that may be applicable in order to meet any deficiencies in the filing.

An informal conference was held on December 8, 2009 for the purpose of discussing Staff's information request and Montgomery District's letter dated November

4, 2009. Montgomery District failed to attend the informal conference, as shown by the sign-in sheet contained in the Appendix to this Order.

Based upon a review of Staff's information request, Montgomery District's November 5, 2009 letter, and Montgomery District's failure to attend the December 8, 2009 informal conference, the Commission finds that Montgomery District should have 10 days from the date of this Order to submit the information requested by Staff on October 30, 2009. If the information requested is not filed within 10 days of the date of this Order, this proceeding will be dismissed without prejudice and without further Order.

IT IS HEREBY ORDERED that:

- 1. Montgomery District shall have 10 days from the date of this Order to submit the information requested by Staff on October 30, 2009.
- 2. If the information requested is not filed within 10 days of the date of this Order, this proceeding will be dismissed without prejudice and without further Order.
