ORDER

On September 21, 2009, Simpson County Water District ("Simpson District") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. Simpson District purchases water from White House Utility District ("White House") and the Warren County Water District ("Warren District").
- 2. White House notified Simpson District that it would increase its wholesale water rates effective October 1, 2009. White House's wholesale water rate to Simpson District would increase from \$1.86 per 1,000 gallons to \$2.1374 per 1,000 gallons. Simpson District proposes to increase the water rates to its customers effective October 1, 2009.
- 3. During the 12 months ending August 31, 2009, Simpson District purchased a total of 359,563,221 gallons of water from White House and a total of 40,000 gallons of water from Warren District and sold a total of 303,201,888 gallons of

water. The increase in the cost of purchased water is \$99,742.84, resulting in a purchased water adjustment of \$0.33 per 1,000 gallons.

4. A purchased water adjustment of \$0.33 per 1,000 gallons is fair, just, and reasonable.

IT IS HEREBY ORDERED that:

- 1. Simpson District's proposed rates are approved.
- 2. The purchased water adjustment increase of \$0.33 per 1,000 gallons as calculated in Appendix A is approved and the rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services rendered on and after October 1, 2009.
 - 3. The tariff sheets filed by Simpson District in the application are approved.
