## ORDER

On October 19, 2007, in Case No. 2007-00089,<sup>1</sup> the Commission approved rates for Delta Natural Gas Company, Inc. ("Delta") and provided for their further adjustment in accordance with Delta's Gas Cost Adjustment ("GCA") clause.

On September 23, 2009, Delta filed its proposed GCA to be effective October 26, 2009. After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. Delta's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. Delta's notice sets out an Expected Gas Cost ("EGC") of \$5.3063 per Mcf, which is a decrease of \$1.0009 per Mcf from the previous EGC of \$6.3072 per Mcf.
- 3. Delta's notice sets out no current quarter Refund Adjustment ("RA"), which is no change from the previous total RA.

- 4. Delta's notice sets out a current quarter Actual Adjustment ("AA") of (\$.1317) per Mcf. Delta's total AA is \$1.3371 per Mcf, which is a decrease of \$1.4816 per Mcf from the previous total AA of \$2.8187 per Mcf.
- 5. Delta's notice sets out a Balance Adjustment ("BA") of \$.0220 per Mcf, which represents an increase of \$.0640 per Mcf from the previous BA of (\$.0420) per Mcf.
- 6. Delta's GCA is \$6.6654 per Mcf, which is a decrease of \$2.4185 per Mcf from the previous GCA of \$9.0839 per Mcf.
- 7. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for final meter readings by Delta on and after October 26, 2009.

### IT IS THEREFORE ORDERED that:

- 1. The rates in the Appendix to this Order are approved for final meter readings on and after October 26, 2009.
- 2. Within 20 days of the date of this Order, Delta shall file with this Commission its revised tariffs setting out the rates authorized herein.
