O R D E R

On November 16, 2009, Henry County Water District No. 2 ("Henry District") filed an application to increase and add certain nonrecurring charges. Henry District proposed an effective date of January 1, 2010. Having reviewed the filing, the Commission finds that it is appropriate to investigate this matter further.

IT IS HEREBY ORDERED that:

1. Henry District's proposed nonrecurring charges are suspended for five months, from January 1, 2010 up to and including May 31, 2010.
2. Henry District shall, no later than December 23, 2009, file with the Commission the original and six copies of the information listed in the Appendix to this Order, with a copy to all parties of record.
 - a. Responses to requests for information shall be appropriately bound, tabbed and indexed and shall include the name of the witness responsible for responding to the questions related to the information provided.
 - b. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or

person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

c. Any party shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect.

d. For any request to which a party fails or refuses to furnish all or part of the requested information, that party shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

4. Identify specific costs included in the \$160.54 site cleanup expense of section F of the cost justification sheets for meter connections.
5. Explain the \$7 transportation expense identified for the reconnection charge.
