O R D E R

On November 20, 2009, Wood Creek Water District – Wastewater Division (“Wood Creek”) applied for approval to adjust its rates pursuant to KRS 278.015.

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Wood Creek purchases sewage treatment services from the city of London (“London”).
2. London notified Wood Creek that, effective for services rendered on and after August 8, 2008, London’s wholesale sewage treatment rate to Wood Creek would increase from \$2.63 per 1,000 gallons to \$2.74 per 1,000 gallons.
3. Wood Creek proposes to pass this wholesale increase in sewage treatment rates to its customers for bills rendered on and after January 1, 2010.
4. During the 12 months ending October 31, 2009, Wood Creek sold 50,925,125 gallons of water and London treated 48,931,500 gallons of sewage from Wood Creek.

5. The increase in the cost of sewage treatment is \$5,382.47, resulting in a sewage treatment rate adjustment of \$0.11 per 1,000 gallons.

6. The sewage treatment rate adjustment of \$0.11 per 1,000 gallons is fair, just, and reasonable and should be approved.

7. The rates proposed by Wood Creek were miscalculated by using a factor that would not recover the increased cost and should be denied.

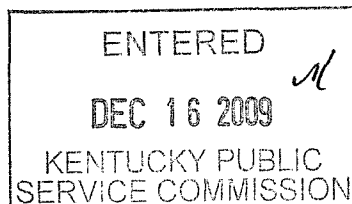
IT IS THEREFORE ORDERED that:

1. The rates proposed by Wood Creek are denied.


2. The sewage treatment rate adjustment increase of \$0.11 per 1,000 gallons as calculated in Appendix A is approved and the rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services rendered on and after January 1, 2010.

3. Within 20 days of the date of this Order, Wood Creek shall file with the Commission revised tariff sheets showing the rates approved herein.
