# ORDER

KRS 74.020(7) requires that this Commission "encourage and promote the offering of high quality water district management training programs that enhance a water district commissioner's understanding of his or her duties." Pursuant to this statutory mandate, the Commission has conducted a training seminar in Frankfort, Kentucky. This seminar included instruction regarding trends in applicable law and regulations and utility administration.<sup>1</sup>

Based upon a review of the course curriculum, the Commission finds that:


1. The course of instruction provided at this seminar would enhance a water district commissioner's understanding of his or her duties.

2. The seminar conducted at Frankfort, Kentucky should be approved for 6.5 credit hours of water district management training.

IT IS THEREFORE ORDERED that the 2009 Last Chance Water Personnel Training Seminar, which the Commission conducted on December 9, 2009 in Frankfort, Kentucky, is approved for a maximum of 6.5 credit hours of water district management training.

#### 8:05 - 9:05 Recent Developments in Utility Regulation – Gerald Wuetcher

A review of the recent developments in public utility law and regulation. Recent changes in Kentucky statutes affecting the operation of water utilities will be discussed. Recent Public Service Commission's decisions that affect water utilities and personnel and organizational changes at the Public Service Commission will also be examined. An update on new Public Service Commission initiatives will also be provided.

Presentation on the critical issues that wholesale water providers and purchasers should consider when negotiating water supply contracts. Presenter discusses various negotiating approaches that will avoid unnecessary litigation and operation and administrative problems.

## 2:15 - 3:15 Tariffs – Brent Kirtley

Presentation on utility tariffs and rate schedules. Presenter will discuss how the contents of the tariff impose legal obligations upon water utilities and the consequences when a utility's practices failed to reflect the provisions of its filed tariff. He will also discussion of various provisions that should be contained in a utility tariff, including rules for water main extensions, landlord-renter provisions, leak adjustments, late payment penalties, deposits, discontinuance of service for non-payment. Presentation also addresses the methods of revising a tariff's provisions and adjusting a utility's rate schedules.

## 3:20 - 4:20 Territory Considerations – Gerald Wuetcher

The legal issues surrounding water/sewer utility service territories will be examined. A utility's obligation to provide utility service within its territory, neighboring utility incursion into a water utility's territory, and the use of 7 USC § 1926 to combat such incursions will be addressed.
