O R D E R

By Orders dated January 25, 2010 and March 29, 2010, the Commission issued procedural schedules for this matter. On April 16, 2010, the complainant, MCI Communications Services, Inc., Bell Atlantic Communications, Inc., NYNEX Long Distance Company, TTI National, Inc., Teleconnect Long Distance Services & Systems Company, and Verizon Select Services, Inc.; the defendants, Windstream Kentucky West, LLC and Windstream Kentucky East, LLC; intervenor Sprint Communications Company L.P., Sprint Spectrum L.P., Nextel West Corp., and NPCR, Inc. d/b/a Nextel Partners; and intervenor BellSouth Telecommunications, Inc. d/b/a AT&T Kentucky and AT&T Communications of the South Central States, LLC moved, jointly, for an

extension of time to file responses to the third round of data requests, which were exchanged on April 7, 2010.¹ The Commission's March 29, 2010 Order stated that the parties were to submit those responses by April 16, 2010; however, the parties jointly agree to an extension of time until April 23, 2010 for submitting those answers.

Having reviewed the request, the Commission finds that the motion shall be granted. The parties shall have until April 23, 2010 to file their responses to the third round of data requests. The March 29, 2010 procedural schedule is amended as provided in the Appendix and shall be followed by all parties to the proceeding.

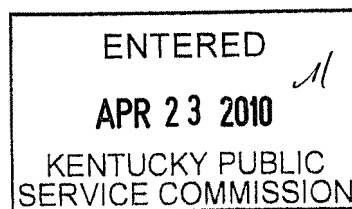
IT IS HEREBY ORDERED that:
