ORDER

On July 6, 2010, the Commission issued an Order ("July 6 Order") granting Nexus Communications, Inc.'s ("Nexus") motion to place this matter in abeyance for the purpose of allowing Nexus time to revise its offering of telecommunications services for low-income federal universal service support. In that Order, the Commission instructed Nexus to file a status report every 60 days. The Commission also stated that it reserved the right to dismiss this proceeding if it determined that it was in the best interest of administrative efficiency to have Nexus refile the petition as a new case.

In compliance with the July 6 Order, Nexus submitted an initial status report on September 2, 2010, wherein it stated that it is engaged in an internal planning process for revising its telecommunications service offerings and that, once that process is completed, it will move to have this proceeding reactivated.

The Commission has reviewed the Orders and pleadings in this matter and has determined that, in the best interest of administrative efficiency, Nexus should file a "Notice of Reactivation" for this case within 120 days of the date of this Order, if it is prepared to immediately proceed with the Petition. In its "Notice of Reactivation," Nexus

should indicate whether it is making any substantive changes to the petition and should include any exhibits in support of those changes. Additionally, the Commission will amend the July 6 Order and will require Nexus to file only one more status report within 60 days of the date of this Order. No other status reports will be required.

IT IS HEREBY ORDERED that:

- 1. Within 120 days of the date of this Order, Nexus shall file a Notice of Reactivation, if it is prepared to immediately proceed with the Petition.
- 2. Within 60 days of the date of this Order, Nexus shall file a status report.

 No other status reports shall be required thereafter.
- 3. If Nexus does not file a Notice of Reactivation, the Commission may dismiss this proceeding by separate Order.
