O R D E R

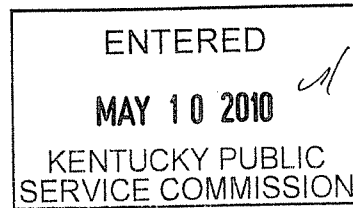

The Commission, being otherwise sufficiently advised, finds that Mr. Murphy should be granted full rights of a party in this proceeding.

IT IS HEREBY ORDERED that:


1. The motion of Joseph Murphy to intervene is granted.
2. Joseph Murphy shall be entitled to the full rights of a party and shall be served with the Commission's Orders and with filed testimony, exhibits, pleadings, correspondence, and all other documents submitted by parties after the date of this Order.
3. Should Joseph Murphy file documents of any kind with the Commission in the course of these proceedings, Joseph Murphy shall also serve a copy of said documents on all other parties of record.

4. Within 14 days of the date of this Order, Joseph Murphy shall file with the Commission a list of the witnesses that he intends to call at the scheduled hearing in this matter and a written summary of each witness's expected testimony.
