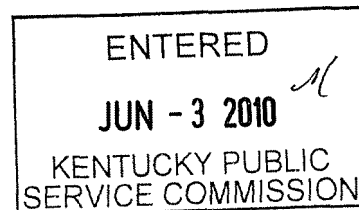
ORDER

Finding that rules regarding the conduct of such hearing are necessary to ensure that evidence is presented in an orderly and efficient manner, the Commission, on its own motion, HEREBY ORDERS that:

1. Preliminary motions in this matter will be heard at the start of the hearing and prior to the parties' opening statements.
2. Each party to this proceeding shall make an opening statement of not more than five minutes in length. This statement shall summarize the party's position in this matter and describe the evidence that the party expects to present at hearing.
3. Opening statements will be made in the following order:
 - a. Estate of John Ford;
 - b. Energy and Environment Cabinet;
 - c. Attorney General; and
 - d. Joseph Murphy.
4. Parties will present their witnesses in the following order:
 - a. Estate of John Ford;
 - b. Energy and Environment Cabinet;

- c. Attorney General; and
 - d. Joseph Murphy.
5. Cross-examination of witnesses will be conducted in the following order:
- a. Estate of John Ford;
 - b. Energy and Environment Cabinet;
 - c. Attorney General;
 - d. Joseph Murphy, and
 - e. Commission Staff.
6. No closing statements shall be permitted.
7. Any party wishing to submit a written brief in this matter shall file such brief with the Commission within 30 days of the close of the hearing record.
8. The Hearing Officer shall address all motions related to identification and admission of all exhibits.
9. Counsel for Commission Staff shall retain custody of all exhibits submitted at hearing. Within 10 days of the close of the hearing record, counsel for Commission Staff shall prepare a written exhibit list and shall file this list with the Commission, along with all exhibits and a copy of the video transcript of the hearing.
