ORDER

On October 6, 2009, Evergreen Disposal System, Inc. ("Evergreen") applied to the Commission for an increase in its sewer rates. The proposed rates would increase rates by 45.6 percent, from \$27.47 per month to \$40.00 per month.

Commission Staff performed a limited financial review of Evergreen's operations and, on March 16, 2010, issued a Staff Report containing its initial findings and recommendations concerning the proposed rates. Pursuant to Evergreen's request, an informal conference was held on April 27, 2010. Based upon the issues raised at the informal conference, Staff amended its original findings and recommendations and issued an Amended Staff Report on July 12, 2010.

All parties were directed to file written comments upon Staff's findings and recommendations or to request a conference or hearing no later than July 26, 2010. No comments were filed and the Commission, having considered the evidence of record and being otherwise sufficiently advised, finds that:

1. The recommendations and findings contained in the Amended Staff Report are supported by the evidence of record and are reasonable.

2. Evergreen's proposed rates will produce annual revenue of \$22,234.

IT IS THEREFORE ORDERED that:

- 1. The findings and recommendations contained in the Amended Staff Report are adopted and incorporated by reference into this Order as if fully set out herein.
- 2. Evergreen's proposed water rates, which are set forth in the Appendix to this Order, are approved for service rendered by Evergreen on and after the date of this Order.
- 3. Within 30 days of the date of this Order, Evergreen shall file its revised tariff with the Commission setting out the rates approved herein.
