ORDER

The City of Greensburg, Kentucky ("Greensburg") has submitted a proposed revision to its existing rates for wholesale water service to public utilities. The Commission established an initial procedural schedule on December 11, 2009. Due to multiple requests for extensions of time by Greensburg to respond to an information request, the initial procedural schedule was amended, and the amended schedule was cancelled. To ensure that the case proceeds in a timely and efficient manner, the Commission finds that it is appropriate to set a procedural schedule. In light of the previous delays and the statutory deadline set by KRS 278.190, the Commission notes that future requests for extensions will be granted only for the most exceptional causes.

Commission Staff set an informal teleconference for March 11, 2010, at which no representatives of Green-Taylor Water District ("Green-Taylor") participated. The Commission, therefore, finds that additional information should be filed by Green-Taylor to properly process this case.

IT IS THEREFORE ORDERED that:

1. The procedural schedule set forth in Appendix A to this Order shall be followed.

- 2. Prior to filing any materials with the Commission, all parties should carefully review documents to ensure that any personal identifiers of a sensitive nature such as social security numbers, tax identification numbers, insurance policy identification numbers, and bank account numbers are redacted, unless the documents are to be filed confidentially under 807 KAR 5:001, Section 7.
- 3. At any hearing in this matter, neither opening statements nor summarization of direct testimony shall be permitted.
- 4. Motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of good cause and under exceptional circumstances.
- 5. All documents that this Order requires to be filed with the Commission shall be served upon all other parties.
- 6. Green-Taylor shall, no later than March 31, 2010, file with the Commission the original and six copies of the information listed in Appendix B, with a copy to all parties of record.
- a. Responses to requests for information shall be appropriately bound, tabbed and indexed and shall include the name of the witness responsible for responding to the questions related to the information provided, with copies to all parties of record and six copies to the Commission.
- b. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the

response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

- c. Any party shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect.
- d. For any request to which a party fails or refuses to furnish all or part of the requested information, that party shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.
- 7. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
