FIRST DATA REQUEST OF COMMISSION STAFF

Pursuant to 807 KAR 5:001, Duke Energy Kentucky, Inc. ("Duke Kentucky") is to file with the Commission the original and seven copies of the following information, with a copy to all parties of record. The information requested herein is due on or before February 15, 2010. Responses to requests for information shall be appropriately bound, tabbed, and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Duke Kentucky shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which

Duke Kentucky fails or refuses to furnish all or part of the requested information, Duke Kentucky shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention should be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations.

- 1. Refer to Appendix B of Duke Kentucky's application, page 1 of 5. In Column (10), 2008 Reconciliation, Electric the over-collection amount of \$15,724 does not agree with the prior period under-collection carry-forward amount of \$49,448 from Case No. 2008-00473¹. Provide an explanation for this discrepancy. Include all workpapers, spreadsheets, calculations, etc. necessary to support the explanation. Provide a revised Appendix B as well as revised versions of any other affected appendices.
- 2. Refer to Appendix B of Duke Kentucky's application, page 3 of 5. Footnote A references Appendix I, page 2; however, there is no Appendix I in the application. Provide the referenced appendix or other revision needed to correct this inconsistency.
- 3. Refer to Appendix B of Duke Kentucky's application, page 5 of 5. Footnote A references Appendix J, page 1; however, there is no Appendix J in the

application. Provide the referenced appendix or other revision needed to correct this

inconsistency.

4. Refer to pages 24-25 of Duke Kentucky's application concerning the new

online energy efficiency website vendor, ACLARA. Provide the status of the transition

to ACLARA and update the impact of this transition to the Energy Efficient Website and

to the Personalized Energy Report programs.

5. Refer to page 11 of Duke Kentucky's application concerning the additional

opportunities for the refrigerator replacement program. Provide any additional

information regarding possible modifications to the program. Include discussion of

prospective increase in benefits, potential cost savings, and customer participation.

6. Refer to page 20 of Duke Kentucky's application concerning the Power

Manager program. Provide all workpapers, spreadsheets, calculations, etc. associated

with the computation of the Variable Daily Event Incentive.
