THIRD INFORMATION REQUEST OF COMMISSION STAFF TO GREEN RIVER VALLEY WATER DISTRICT

Green River Valley Water District ("Green River Valley"), pursuant to 807 KAR 5:001, is to file with the Commission the original and ten copies of the following information, with a copy to all parties of record. The information requested herein is due within 14 days of the issuance of this request. Responses to requests for information shall be appropriately bound, tabbed and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a government agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Green River Valley shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or,

though correct when made, is now incorrect in any material respect. For any request to which Green River Valley fails or refuses to furnish all or part of the requested information, it shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations.

- 1. Refer to Green River Valley Water Districts cost of service study, wholesale rate calculation. Explain how each of the amounts for debt service were distributed between pumping and treatment, transmission and distribution, and customer. If these amounts were derived from another table or chart, reference where they are located.
- 2. Explain how each amount for debt service was allocated between wholesale and retail. An amount of \$13,585 is allocated to wholesale and \$284,800 to retail for pumping and treatment and an amount of \$218,451 to wholesale and \$695,124 to retail for transmission and distribution. How are these amounts calculated?
- 3. Explain where the amount of \$110,047 allocated as new debt to serve wholesale is derived. How is it calculated?
- 4. Explain how and why the costs for depreciation were distributed between depreciation on new construction, transmission and distribution, and customer. Further explain how each amount was calculated and how that amount was then allocated
