O R D E R

This matter arises upon the motion for limited intervention of Pike County Senior Citizens Programs, Inc. ("Pike Senior Citizens"), filed January 27, 2010. It appears to the Commission that Pike Senior Citizens has not requested full intervention and that limited intervention will not unduly delay or disrupt the proceedings or prejudice the rights of the original parties. The Commission, being otherwise sufficiently advised, finds that Pike Senior Citizens should be granted full rights of a party at any hearing and should be served with the Commission's Orders, but should not be served with filed testimony, exhibits, pleadings, correspondence, and other documents submitted by parties and should not be certified as a party for the purpose of receiving service of petitions for rehearing or petition for judicial review.

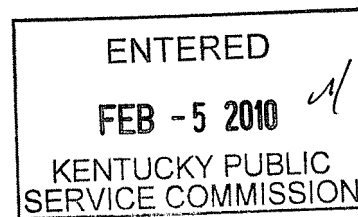
IT IS HEREBY ORDERED that:

1. The motion of Pike Senior Citizens for limited intervention is granted.
2. Pike Senior Citizens shall be entitled to the full rights of a party at any hearing and shall be served with the Commission's Orders, but shall not be served with filed testimony, exhibits, pleadings, correspondence, and all other documents submitted


by parties and shall not be certified as a party for the purpose of receiving service of any petitions for rehearing or petition for judicial review.
