O R D E R

On February 26, 2010, Kentucky Power Company ("Kentucky Power") filed a petition requesting confidential protection of highlighted portions of its responses to the Attorney General's Office, Rate Intervention Division ("AG"), First Request, Item Nos. 47 and 51. On March 17, 2010, the AG filed a motion requesting a hearing on the issue of whether or not Kentucky Power's data responses were entitled to confidential protection. Kentucky Power then filed, on April 1, 2010, a revised request seeking confidential protection of a lesser portion of its previously filed data responses.

Kentucky Power and the AG, by joint motion filed on May 24, 2010, state that they have reached an agreement that this issue of confidentiality should be determined on the existing record without a hearing, and the AG has agreed to withdraw his pending motion for a hearing.

The Commission, having considered the May 24, 2010 joint motion and finding good cause, HEREBY ORDERS that:


1. The AG's request to withdraw his motion for a hearing on the issue of confidentiality is granted.

2. The issue of confidentiality shall be determined on the existing record.
