ORDER

On December 11, 2009, Bath County Water District ("Bath County") applied for approval to adjust its rates pursuant to the Purchased Water Adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. Bath County purchases water from the City of Morehead Utility Plant Board ("Morehead") and Mt. Sterling Water.
- 2. Morehead notified Bath County that, effective with its January 1, 2010 billing, its wholesale water rate would increase from \$0.95 per 1,000 gallons to \$0.996 per 1,000 gallons. Bath County proposed to increase the water rates to its customers effective on and after January 1, 2010.
- 3. During the 12 months ending November 30, 2009, Bath County purchased 406,023,000 gallons of water from Morehead. Bath County sold a total of 357,154,000 gallons. The increase in the cost of purchased water is \$18,677.06,

resulting in a purchased water adjustment of \$0.06 per 1,000 gallons and not \$0.05 per 1,000 gallons as proposed by Bath County.

4. Bath County incorrectly applied the purchased water adjustment of \$0.05 per 1,000 gallons to its current rate design. The rates proposed by Bath County should be denied.

5. The purchased water adjustment of \$0.06 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

- 1. The rates proposed by Bath County are denied.
- 2. The purchased water adjustment of \$0.06 per 1,000 gallons, as calculated in Appendix A, is approved.
- 3. The rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services rendered on and after January 1, 2010.
- 4. Within 30 days of the date of this Order, Bath County shall file new tariff sheets showing the rates approved herein.
