ORDER

On February 24, 2010, the Applicant in the above-styled case, ecoPower Generation, LLC ("ecoPower"), filed with the Kentucky Secretary of State Articles of Amendment to its Articles of Organization changing its name to "ecoPower Generation-Hazard, LLC." On April 5, 2010, ecoPower Generation-Hazard, LLC filed a response to Staff's Second Data Request in which it requests that its application "be amended to reflect the change of its name to ecoPower Generation-Hazard, LLC."

The Kentucky State Board on Electric Generation and Transmission Siting ("Siting Board") finds that, in order to change the name of the Applicant on the application, the Applicant must submit a motion to amend its application, explaining the reason for the February 24, 2010 name change and positively identifying the Secretary of State's Organization Number of the entity which is the Applicant in this matter.

Although the Siting Board notes that ecoPower's February 24, 2010 filing with the Kentucky Secretary of State has caused some confusion, it should not alter the Siting Board's ability to timely complete its review.

Wherefore the Siting Board HEREBY ORDERS that within seven (7) days of the date of this Order ecoPower shall file a motion to amend its application to reflect the name change effectuated by its February 24, 2010 filing with the Kentucky Secretary of State.
