O R D E R

On October 19, 2007, in Case No. 2007-00089,¹ the Commission approved rates for Delta Natural Gas Company, Inc. ("Delta") and provided for their further adjustment in accordance with Delta's Gas Cost Adjustment ("GCA") clause.

On December 21, 2009, Delta filed its proposed GCA to be effective January 25, 2010. Delta filed a revision to its proposed GCA on January 7, 2010. After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Delta's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
2. Delta's notice sets out an Expected Gas Cost ("EGC") of \$5.7166 per Mcf, which is an increase of \$.4103 per Mcf from the previous EGC of \$5.3063 per Mcf.
3. Delta's notice sets out no current quarter Refund Adjustment ("RA"), which is no change from the previous total RA.

4. Delta's notice sets out a current quarter Actual Adjustment ("AA") of \$.0407 per Mcf. Delta's total AA is \$.4092 per Mcf, which is a decrease of \$.9279 per Mcf from the previous total AA of \$1.3371 per Mcf.

5. Delta's notice sets out a Balance Adjustment ("BA") of (\$.0900) per Mcf, which represents a decrease of \$.1120 per Mcf from the previous BA of \$.0220 per Mcf.

6. Delta's GCA is \$6.0358 per Mcf, which is a decrease of \$.6296 per Mcf from the previous GCA of \$6.6654 per Mcf.

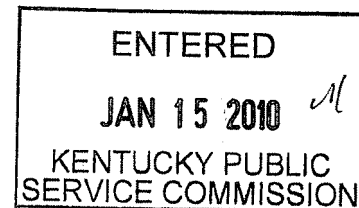
7. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for final meter readings by Delta on and after January 25, 2010.

IT IS THEREFORE ORDERED that:


1. The rates in the Appendix to this Order are approved for final meter readings on and after January 25, 2010.
