O R D E R

The matter is before the Commission upon a motion filed by the Kentucky Cable Telecommunications Association (“KCTA”) for an extension of time to file its supplemental data requests. In support of its motion, KCTA states that its lead counsel will be involved in a trial in Florida that is expected to last through March 29, 2010. Because of this scheduling conflict, KCTA informs that its lead counsel will not be able to fully review KCTA’s data requests to be propounded to Louisville Gas and Electric Company (“LG&E”) and Kentucky Utilities Company (“KU”) prior to the March 26, 2010 deadline for the filing of supplemental data requests.

KCTA asserts that its lead counsel “is the KCTA counsel with sufficient institutional knowledge, and expertise in rate cases and the Commission’s rate formulas, to determine what additional data KCTA may need to fully evaluate the propriety of [LG&E’s and KU’s] proposed pole-attachment rates.” Accordingly, KCTA requests a one-week extension of time to file its supplemental data request and a corresponding one-week extension of time for LG&E and KU to file their responses. 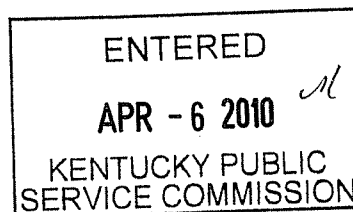
allowed the extensions of time, KCTA states that it would not seek additional time to file its testimony. Lastly, KCTA advises that LG&E and KU have no objection to this request.

Having reviewed the motion and being otherwise sufficiently advised, the Commission finds that good cause exists to grant KCTA's motion.

IT IS THEREFORE ORDERED that:

1. KCTA's motion for an extension of time to file its supplemental data requests is granted.
2. KCTA shall file supplemental data requests no later than April 2, 2010.
3. LG&E and KU shall file responses to KCTA's supplemental data requests no later than April 15, 2010.
4. All provisions of the Commission's Scheduling Order of February 16, 2010 that do not conflict with this Order shall remain in full force and effect.
